TERMS & CONDITIONS

- 1. Payment of Fees
- The Enrolment Fee is payable upon enrolment and is nonrefundable.
- b. Full payment of fees specified as the first instalment on the letter of offer from AIT must be received by the due date on the letter of offer from AIT.
- For on-going students, any additional instalment fees must be paid by the date specified by AIT.
- d. Fees are subject to change. However, fees detailed in a letter of offer issued before the date of change will be honoured by AIT for the period/course stated on the letter of offer.
- Students repeating units of study will be required to pay for such repeated units.
- 2. Visa Application Refused (Overseas Students)

Student is entitled to a full refund of tuition fees when the student provides AIT evidence from the Australian Department of Immigration and Citizenship (DIC) that the student's visa was refused before their first entry to Australia.

3. Student Default

If the student withdraws from a course after the payment of all fees, refunds will been made within 4 weeks of notification of default from the student in writing and the following will apply:

- a. Prior to commencement
 - If the student gives at least 4 weeks notice of withdrawal from an enrolment to course(s) before the commencement date, a refund of fees, minus:
 - The fees noted under section 1.a
 - 25% of the course tuition fee.
 - ii. For all other students who fail to give at least 4 weeks notice of withdrawal from an enrolment to course(s) before the commencement date, a full refund minus:
 - The fees noted in section 1.a
 - 40% of the course tuition fee.
- b. After commencement

If the student requests to withdraw from an enrolment to course(s) on or after the commencement date of the initial course, there will be no refund of fees.

All applications for refunds must be made in writing stating the reasons and relevant details to the Administrator. This policy does not remove the right to take further action under Australia's Consumer Protection Laws nor does it prevent the student from pursuing other legal remedies. Students are bound by the conditions of their respective visas when changing their education provider. Students who change provider are regarded as students withdrawing after commencement of their program. When granted, refunds will be paid to the person that originally paid the fees to AIT within 4 weeks of written notification.

4. Notice of Withdrawal

If a student is in a situation where they need to apply for withdrawal, they must do the following:

- Apply in writing to the Administrator
- State his/her name, student number and contact details
- State program, commencement date and reason for withdrawal Notices will not be effective until received by AIT.
